Dear PM Martin/PMO , Regarding a telephone discussion on the 17th of Mar/05 with personnel in the Correspondence section of the PMO the question was raised , "What do you want the PM to do for you Mr. Greenhalgh?" Ans., in the best interest of the public good ,call for a public inquiry into the criminal and unethical activity that the University of Waterloo has engaged in and has been covered up by many. A public inquiry would be good for the public interest. Basis for this request ; see the attachment dated 13 Mar. 05 sent to the RCMP-PCC titled , "Intent to Deceive : the Holocaust Denial and the University of Waterloo's False Assurances." The RCMP' investigation has now been proven ,if not inadequate, a blatant cover up. This should be a grave concern to the PM. The major concern of the public health and safety has been raised to the PMO many times. If UW will blatantly lie, why won't researchers developing new vaccines? Were you telling the truth? I am claiming that my Charter Rights were violated by the University of Waterloo so they could commit a criminal act. Subsequent prime ministers, notably Chretien promoted a conspiracy to protect the University of Waterloo from facing criminal charges in order avoid setting a precedent: i.e., many universities are corrupt and can easily fend off private citizens, but if it was shown that they were responsible to federal law , then they would be held accountable for many wrongs they have previously gotten away with. Ordinary citizens would be able to hold Rich Privileged elitists like Douglas Wright accountable for his arrogant actions.
