The Proposal in Its Most Basic Form

This document talks about what the Gate's Foundation is asked , what it will receive and how this benefits humanity.

Premise 1. Dr. Kary Mullis , nobel prizewinner, said most cancer researchers are lying to keep their jobs. 50 +yrs have passed since the formation of the ACS w/o a cure for cancer. In 1987 , E.A.Greenhalgh proposed the Cell Death Signal Gene and was blacklisted.
