Dear Merk Foundation, This email is an inquiry to the Foundation's meeting od the 10th of November and I've had political difficulties from my detractors in the past . Please note the Attachment sent to PM Martin discussing issues of importance to this topic. I had asked you to judge not only myself but my detractors as well. I had approached you because you apparently pulled Vioxx off the market yourselves, this was admirable. Regarding my detractors and less admirable characterisitics , it has been expected of me to always hold the high ground irregardless the lack of resources available to me and the resulting hardships , and yet this is not expected of them . Case in point, UW's Chancellor , Lazaridis /RIM expects to make money in the US but not respect your laws, i.e., RIM has lost a lawsuit in patent infringement to a Virgina firm ,NTP ; which is precisely my concern with UW , intellectual rights plus their felony actions. I point this out because I am concerned you , in your failure to reply have had political pressure put on you. Please note, how can I be a trouble maker when by their own unethical actions they repeat their misdeeds on an American firm who has no connection to me. UW/RIM's actions must be seen to describe the ethics (bad) that constitute that institutions very fibre . Please consider the logic; others have suffered at their hands.

Toyota is now the number one car maker in the world , while the Plymouth and Oldsmobile business models used outdated ideas and they are extinct. Toyota motors power GM cars, and the new Ford hybrid will be a liscensed Toyota design. Toyota has successfully applied creativity and high standards . Creativity comes from good people (like me) , **but** more importantly , the Toyota executive have recognized and nurtured these people : Plymouth and Oldsmobile did not. In all fairness , the amount of capitol you are asked to invest in my proposal should not require a great deal of time to consider as it is really miniscule in comparison to your company size, yet, the return on this investment must be viewed as hugely potential : like velcro or Bakelite. That then leaves only one question, **the Merck Model** : are you a Lexus or a Plymouth?

M.MacMillan for her Paris 1919 book. There are many examples of scientists being granted funding to develop theoretical formats and books. The basis is the proven Cell Death Signal Theory first documented in 1987 as an original concept and now expressed by the whole scientific community. I have been a positive influence on science and for the good of society. Merck may benefit from seeing the new theories first.
